Auszug aus dem Lizenzvertrag Abridged version of License Agreement

The following provisions apply to Participating Institution's access to and use of the Subscribed Content:

## A. Authorized Users

Effective for the duration of the Subscription Year, and subject to the Participating Institution's compliance with the terms and conditions of this Agreement, the MIT Press grants unlimited access to the full text of the Subscribed Content on the MIT Press Direct platform, <a href="http://direct.mit.edu">http://direct.mit.edu</a>, to the Participating Institution's Authorized Users. There are no contractual limits on the number of Authorized Users from the Participating Institution.

"Authorized Users" are the employees, faculty, staff, students, alumni, and walk-in library patrons using the Participating Institution's library facilities.

## **B.** Permitted Uses

An Authorized User may

- 1. Download chapters and other similar quantities of Subscribed Content for personal use, and archive similar quantities of such material on his/her own personal computer. Note: the purpose of this is to enable research-driven, as-needed downloading.
- 2. Print out chapters and other similar quantities of Subscribed Content for personal use.
- 3. Distribute one copy of a chapter or other similar quantity of Subscribed Content by email, hard copy or fax to one person at another location for that individual's personal use as above, without altering or obscuring any copyright or other identifying information.
- 4. Use the Subscribed Content to perform and engage in text and/or data-mining activities ("TDM") for academic research, scholarship, and other educational, noncommercial purposes; utilize and share the results of TDM in the Authorized User's scholarly work with proper attribution; and make the results available for use by others for the foregoing purposes; all provided the Authorized User's work product is not such as would substitute for the Subscribed Content, a substantial portion of any monograph included in the Subscribed Content, or any material subset of the Subscribed Content. TDM may be conducted only where special access has been granted by MIT Press; no extra fees shall be charged for such access. TDM conducted by the use of scripts or scraping in order to extract content from MIT Press web sites is not permitted. Downloaded metadata and Subscribed Content may be stored locally for the duration of a TDM project but must be permanently deleted upon completion of the project.
- 5. Make traditional scholarly re-use of material within the bounds of fair use.
- 6. Provide to any authorized users of another library via paper, fax or digital transmission, a single facsimile image (e.g., a PDF file) of an individual chapter or similar quantity of Subscribed Content that is an exact representation of the print pages, or a printout of an electronic file, for interlibrary loan within Germany only.
- 7. Place copies of limited excerpts from the Subscribed Content not to exceed, except in unusual circumstances, a single chapter or comparable quantity in "e-reserves" for the use of students in a particular course on a password-protected basis, provided that any material placed in e-reserves will be deleted at the conclusion of the course to which it relates. For the avoidance of doubt: material may be maintained in e-reserves until the end of such course even if this license shall have terminated sooner. Copyright and other identifying information attached to the material concerned may not be

altered or obscured when the material is placed in e-reserves. If the posted material does not contain a copyright notice, full bibliographical information should be posted with it.

All other uses are prohibited.
